


Planning is a strategic function of the Universidad de Antioquia, which is materialized from the intersection of different processes, both transversal and specific, which tend toward a future perspective in institutional, organizational and knowledge fields and disciplines. Planning is also connected to the management of plans, programs and projects and to the intelligent management of information, evaluation and knowledge. Its central task aims to balance the actions that are formed in the virtuous integration between a formulation focused on development and transformation, active participation and informed decision-making processes. Besides, its implementation is validated in the expected purposes.

In planning terms, the University is governed by an Institutional Development Plan with a minimum ten-year periodicity and by three-year action plans in charge of the academic and administrative units.

The Institutional Action Plan integrates the respective plans of the vice-rectories and heads of the Central Administration; it is issued for a term that corresponds to the term of the Rector; and contributes to the materialization of the Development Plan based on programs, metrics and projects.

The Institutional Action Plan of the Universidad de Antioquia -PAI- 2021-2024 was approved by Superior Resolution 2454 of July 27, 2021. It comprises fourteen (14) programs, forty (40) indicators, and sixty-six (66) projects. The plan consolidates priority needs, expectations, interests and challenges of the university community aimed at the improvement, development and transformation of the Alma Mater in its different dimensions: the institutional, academic-disciplinary and organizational ones. The Institutional Action Plan contributes to the materialization of the Institutional Development Plan 2017-2027. In addition to this, it contributes to position the University with a proactive-adaptive attitude to face the multiple scenarios that are presented to us as a society, country and institution, especially during the COVID-19 pandemic.
